The minimum number of ordinary members (continuing in office and to be elected) from any electoral region is one (apart from region 11 [Hong Kong], where it is two). To fulfil this requirement, at least one candidate from region 10 (Rest of Europe, Middle East, Africa and the Americas) must now be elected. There is no maximum number from any region.
