Our report of voting in the above election, which closed yesterday at noon, is as follows.

Election of Ordinary Council Members

Number of votes found to be invalid (including blank forms):	202
Total number of valid votes to be counted:	2,535

The minimum number of ordinary members (continuing in office and to be elected) from any Electoral Region is 1 (apart from Region 11 (Hong Kong), where it is 2). To fulfil this requirement, at least one candidate from Region 1 (Lancashire and Cheshire) and Region 4 (Bedfordshire and Adjoining Counties, East Anglian and East Midlands) must now be elected. There is no maximum number from any region.

Subject to this overriding condition, the election was conducted using the first-past-the-post method of voting.

As only one candidate has been nominated in Region 4 (Richard P W Lankshear) he is automatically **elected**.
