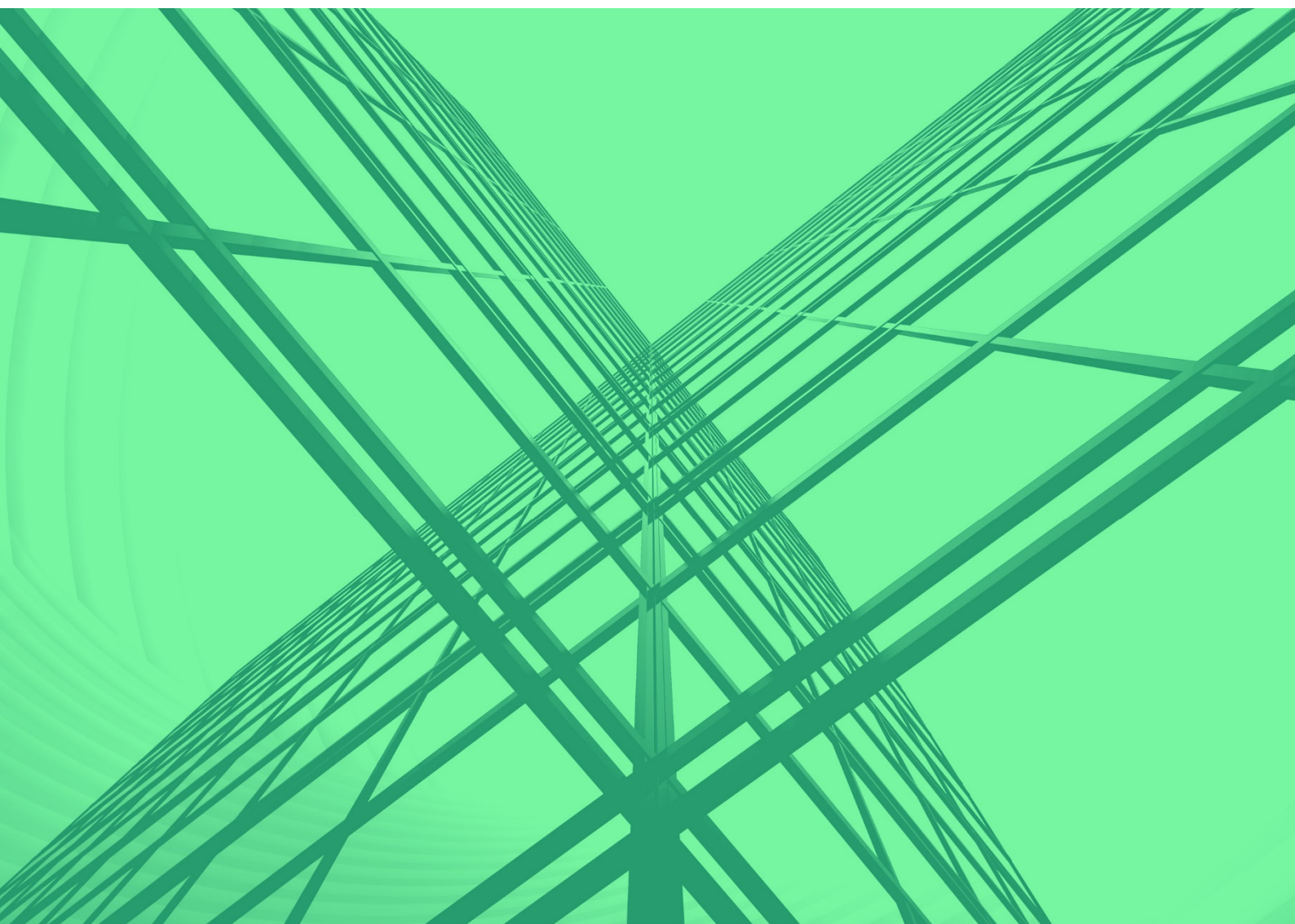


# The Council
